The National University of Singapore Business School (NUS) is one of the eleven schools in the National University of Singapore. The school's degree programs offer students a global perspective with an Asian focus. These programs include the BBA, MBA, International MBA (jointly conducted with Peking University), Asia-Pacific MBA, UCLA-NUS EMBA, MSc (in research-based programs) and the Doctor of Philosophy.

With a distinguished international faculty body educated in renowned universities including Harvard, Wharton, MIT, Oxford and many others, NUS Business School offers the best of global knowledge with deep Asian insights, preparing students to lead Asian businesses to the forefront of the world economy and to help global businesses succeed in Asia.

The school has consistently received top rankings in the Asia-Pacific region by independent publications and agencies, such as *Financial Times*, *Economist Intelligence Unit* and QS Top MBA in recognition of the quality of its programs, faculty research and graduates. NUS was ranked 1st in the 2023 *QS World University Rankings* and their MBA Program was ranked number 25 in the 2023 *Financial Times Ranking*.

FACILITIES/HOUSING

Located about 12 km from the city center, the University's main campus at Kent Ridge occupies a prime location with scenic views of Singapore. It is well served by transportation links, being 20 minutes by car from the airport, close to one of Singapore's main expressways, served by several bus routes and familiar to taxi drivers.

Library facilities, banking facilities, postal services, computer services, telephone services, sports and recreation facilities, and health services are available on campus.

NUS does not provide on-campus accommodation for MBA exchange students, but the school will provide exchange students with private accommodation options.

NUS does not provide on-campus accommodation for MBA exchange students. However, its MBA office and Office of Housing Services work together to provide alternative on-campus accommodation, Kent Vale Apartment, for MBA Exchange students. Students are advised to take a minimum of 3 modules (12 modular credits = 12 USC units) to a maximum of 4 modules (16 modular credits = 15 USC units)

1 NUS credit = 1 USC credit Minimum Units: 12 NUS units = 12 USC units
Maximum Units: 16 NUS units = can earn only 15 USC units
